WHEREAS, The State of New York amended Title Two, Section Three Hundred Fifteen Point Four of the New York Codes, Rules and Regulation to add additional reporting requirements for Elected or Appointed Official who participate in the New York State Retirement System; **NOW**

BE IT RESOLVED BY THE TOWN BOARD AS FOLLOWS:

SECTION 1. The Town Board hereby establishes the following as a standard workday for elected and appointed officials and will report the following days worked to the New York State and Local Employees' Retirement System based on the record of activities maintained and submitted by these officials to the clerk of this body:
